

WHAT THIS MEANS TO YOU



Vhat is Bishop Fernandes' ecision for our consortium?

- Paul, Holy Trinity & St. Sylvester will remain open as churches.
 - One newly established canonical parish will be formed.

Why is it necessary to merge into one parish?

The result of Real Presence Real Future was that all three parishes will remain open but merge financially to simplify procedures and have more efficient use of resources.

 The three parishes of our consortium will be issued a Decree of Suppression, and one parish will be formed. All three churches will remain places of divine worship.

SUPPRESSION by definition is a decree issued by the bishop that ceases a parish's existence, but the church itself remains open as a place of divine worship.


Our finance committee

 - Responsibilities: Create/Draft flyer with important information regarding the transition with getting accurate and clear communication to all parishioners
 - iii. Flyer from Ross-Pike Catholic Consortium was shared. Team members providing suggestions to emphasize no changes upcoming in mass times and a section about "why parishioners should care"

 - i. Terese Cutright to be added to team

MEETING TOPICS DISCUSSED PER AGENDA

- Catholic Foundation Discussion regarding current endowments with Dan Kurth from the Foundation.
 - a. Reviewed process of amending endowments and the processes in which to do so. Goal is for funds to be amended by the official merge date before current parishes are formally suppressed.
 - b. Among the three parishes there are a total of 8 endowments
 - i. 4 of these endowments are to be amended with the signature of Father Herge
 - ii. 4 of these endowments are to be amended through an abbreviated process through the Attorney General's office.
 - c. In order to start this process, the name of the new parish is to be established and the suppression letter is to be issued.
- II. Financial Inquiry with Pam Downard
 - a. Once new parish name established the federal ID will need to be changed to a new name
 - b. Checking account and financial accounts are to be merged
 - c. There will remain separate accounts for the cemeteries
 - d. Mass intentions will be merged
 - e. All utilities/bills will be updated to reflect new name
- III. Subcommittee Review
 - a. Vision/Mission/Patron Saint Sub-Committee
 - i. Possible names discussed St. Hubert, Divine Mercy, and St. Paul the Apostle
 - ii. Father to have draft letter for the bishop hopefully by next meeting with the suggestions of St. Hubert and Divine Mercy
 - iii. New Parish Mission and Vison Statement

- Discussed the designation of money
- Discussed names of the new parish
- Overall, there was a good sense of community and understanding of the merge
- Father will email the Bishop the name suggestion of Divine Mercy for new Parish Name.
